# APPENDIX NOTIFICATION

In exercise of the powers conferred by section 30 of the Registration of Births and Deaths Act, 1969 (Central Act 18 of 1969), the Governor of Tamil Nadu, with the approval of the Central Government, hereby makes the following amendment to the Tamil Nadu Registration of Births and Deaths Rules, 2000.

# AMENDMENT

In the said Rules, in rule 9, for sub-rule (3), the following sub-rule shall be substituted, namely:-

"(3.) Any birth or death which has not been registered within one year of its occurrence shall be registered by an order of the Executive Magistrate not below the rank of a Revenue Divisional Officer."
